Rights of Survivorship Ownership Agreement for a Motor Vehicle

Instructions

Submit completed form to your local County Tax Assessor-Collector's office with a completed Form 130-U, to place a "Rights of Survivorship" remark on the vehicle title record. Type or print legibly in black or blue ink. Additional information on page 2.

Vehicle Information: the motor vehicle described below from this day forward will be held jointly, and in the event of the death of any person named in this agreement, the ownership of the vehicle will transfer to the survivor(s).

Rights of Survivorship Agreement

General instructions for all applicants:

A motor vehicle is jointly owned when two or more persons complete a Rights of Survivorship agreement, even if only one of them is the recorded owner. If one or more of the persons that completed a Rights of Survivorship agreement dies, ownership of the vehicle automatically goes to the other persons that signed the agreement.

- A vehicle does not have to be titled or registered in the names of all persons in the agreement. To transfer ownership of the vehicle, all persons shown in a Rights of Survivorship agreement must act jointly before the death of any party of this agreement.
- A notary is required, unless the persons who sign are legally married to each other and will jointly hold ownership of the vehicle.
- All persons shown in a Rights of Survivorship agreement must act jointly if ownership of the vehicle is to be transferred.

To have the "RIGHTS OF SURVIVORSHIP" remark placed on the title:

When one or more persons submit an application for title and a jointly signed Rights of Survivorship agreement, the remark "RIGHTS OF SURVIVORSHIP" will be placed on the title by the department. After the death of any of the person(s) named in the agreement, the survivor(s) may obtain a new title by submitting an application for title.

- A new application for title must be completed by the survivor(s).
- A copy of the deceased person(s) death certificate must be presented.

To not have the remark "RIGHTS OF SURVIVORSHIP" placed on the title:

If the persons completing this Rights of Survivorship agreement do not want to have the "RIGHTS OF SURVIVORSHIP" remark recorded on the title, this agreement may be retained in their records along with the vehicle title. After the death of any of the person(s) named in this agreement, the survivor(s) may obtain a new title by submitting an application for title.

- A new application for title must be completed by the survivor(s),
- The completed VTR-122 Rights of Survivorship Ownership Agreement for a Motor Vehicle must be presented,
- A copy of the deceased person(s) death certificate must be presented.

To Revoke a Rights of Survivorship Agreement:

- All person(s) who initiated the Rights of Survivorship agreement must complete the title assignment to transfer the title, and
- The title must be surrendered with the application for title.

Additional instructions for legally married couples (see check box #1, page 1):

A legally married couple is not required to submit any documentation to verify they are married.

Additional instructions for persons not married to each other (see check box #2, page 1):

- All parties to the Rights of Survivorship must complete the application, and
- Have the form notarized

Additional instructions for persons married to one of the applicants for survivorship, but not a party to the rights of survivorship agreement (see check box #3, page 1):

- The spouse not signing the Rights of Survivorship agreement must complete the application, agreeing to the statement that the vehicle is separate property and they are not part of the agreement and have no interest in the motor vehicle, and
- Have the form notarized
